- School personnel, site council representatives, board members and the district English advisory council members met on several occasions to discuss COVID-19 prevention and mitigation strategies to continuously and safely operate schools for in-person learning. The school Plan for Safe Reopening (found on the district website: [www.hmesd.org](http://www.hmesd.org)) specifically outlines and addresses the strategies that were developed.
- School personnel, site council representatives, board members and the district English advisory council members met on several occasions to design summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs. The district will offer a robust summer enrichment program, including field trips, science, music and art. The Boys and Girls Club will continue to operate after school and academic enrichments/ interventions will be addressed with the support of additional classified staff.

- School personnel, site council representatives, board members and the district English advisory council members met on several occasions to discuss which programs will be utilized as a tool for progress monitoring to ensure interventions address the academic, social, emotional, and mental health needs for all students, especially those students disproportionately impacted by COVID-19. The team has selected STAR reading assessments, MAP assessments and the DataZone SEL survey to provide on-going, timely data that reflects academic and social emotional needs and or progress.

A description of how the development of the plan was influenced by community input.

Stakeholders, which include parents, community members, Board members, English Language Advisory Council, School Site Council members and unions met on several occasions (March 17, 2021, March 24, 2021, March 31, 2021, April 21, 2021) to discuss student engagement and student achievement. At the initial meeting, all stakeholders attended via zoom and were assigned breakout groups to analyze student MAP data in the areas of ELA and Math. Upon closure of the meeting, sub-groups were reassigned and groups were given the task of formulating how Howell Mountain ESD might use the data to draft viable action steps for the district LCAP. In addition, groups were encouraged to "Dare to Dream" by proposing actions that would meet district's needs. The next LCAP meeting was designed as an in-person, COVID-19, safe gathering. Each stakeholder was provided with a picture card stating: mathematics, reading, SEL, Science/Social Studies, ELL or Fine Arts. Each group had a poster paper attached to the wall and socially distanced chairs in front of each poster. A staff member was assigned to lead each group. Teams were provided 3 minutes to brainstorm ideas of LCAP actions for each poster. Teams rotated around the room in timed increments to add to existing ideas on the posters. The administrator observed and heard all participants actively engaged throughout the process. The culmination was a "gallery walk" to each poster and a report out from the original team. A common theme of the meetings included ways in which teachers could continue to be stimulating and creative while meeting standards. Stakeholders brainstormed how authentic learning opportunities may be found in the unique K-8 Howell Mountain Elementary setting. Howell Mountain is a small, rural school district that is surrounded by native wildlife and foliage. Stakeholders also discussed strategies that might strengthen community and parent partnerships. The district is located less than a mile from the Pacific Union College, the fire department and is surrounded by eco-sufficient wineries, with livestock and gardens. Stakeholders teased out areas of focus for the Howell Mountain ESD. These areas include Social Emotional Learning and gardening opportunities.

A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

- Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
- Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
